### **Regular NMMA Member Dues:**

NMMA Membership is open to the four divisional classifications below. For manufacturers, Membership dues are based on North American annual sales in the marine industry and Associate service providers pay a flat rate of \$650 per year. **Eligibility Restriction – a retail dealer, supplier or distributor of marine products is NOT eligible for membership with NMMA.**

- Boat Manufacturer Division (BMD)
- Accessory Manufacturer Division (AMD)
- Engine Manufacturer Division (EMD)
- Associate Member – limited to *only service providers* in the marine industry.

Regular NMMA Members either manufacture or import a marine product. Annual dues are based on the total marine sales within North America, in addition to exports from North America, for your company's most recently completed fiscal year. Companies with one or more marine divisions that will have dues paid by a single entity should combine the sales volume of each entity to reach the dues amount for all organizations.
