The National Marine Manufacturers Association Hall of Fame was established in 1988 to recognize and honor individuals who have made or continue to make substantial contributions to the advancement of the marine industry.

HALL OF FAME NOMINATION CRITERIA

Nominees must be:

- An individual who has made a substantial and lasting impact on the industry or their particular segment
- Known in the industry
- Beyond personal or professional reproach
- A past or current member and supporter of NMMA
- Actively involved in the marine industry for a minimum of ten years

NOMINATION PROCESS

Only active members in good standing with the NMMA may submit a nomination. To submit a candidate, complete the formal Hall of Fame nomination form and send to Rachel Harmon, rharmont@nmma.org.

Upon receipt of the nomination, a Dropbox account will be created for each nominee. All supporting documentation, images and letters of recommendation should be uploaded to this account. Deadline for submission is July 15, 2020.
