#### SECTION III: MEMBERSHIP / CERTIFICATION / DISCOVER BOATING

Becoming an NMMA Canada boat manufacturing member requires: 1) compliance with NMMA Certification requirements and 2) support of Discover Boating through the applicable assessments.

MEMBERSHIP: Boat Manufacturer Division (BMD)—A business entity that manufactures or imports boats.

NMMA Certification of BMD product is a requisite for membership within 12 months of joining NMMA Canada. Completion of NMMA Certification is required prior to receiving the discounted member rate at NMMA Boat Shows.

All BMD members are required to pay the Discover Boating Membership fee.

BMD applicants outside North America must have a certificate of authority from at least one province/state of Canada/United States showing it is legally authorized to conduct business in that province/state, thereby submitting to its jurisdiction.

BMD Member Dues Schedule: Annual dues are based on the total North American marine sales (Check the appropriate category, plus GST/HST.)

#### **Approval Procedures:**

Upon receiving an application, NMMA Canada will review it and conduct such investigation as it deems necessary to determine whether the Applicant satisfies the membership qualifications. Upon NMMA Canada's preliminary determination that the Applicant qualifies for membership, NMMA Canada will electronically inform the Applicant within 2 business days that its application has been conditionally accepted, pending formal approval of such application by the NMMA Canada Board of Directors. Pending NMMA Canada Board approval, Applicant will have the status as a member. NMMA Canada will notify the Applicant in writing promptly after the Board of Directors approves its membership in NMMA Canada. If the Board of Directors does not approve such Applicant's membership, Applicant's conditional membership shall immediately terminate and a pro rated portion of such Applicant's dues payment will be returned to the Applicant.

#### **SECTION VII: CERTIFICATION AND DISCOVER BOATING REQUIREMENTS**

#### NMMA CERTIFICATION



NMMA's Engineering Certification platform (ECT) allows members to upload model information, schedule inspections, manage timeline reminders, assign certification specialists, and electronically sign documentation.

The following checklist details the steps to complete NMMA Certification within 12 months of membership approval. Details for each item are outlined in the NMMA Boat Builders Handbook:

- **1. Annual Certification Fee and Inspection Deposit Fee**—Submit the \$3,050 certification deposit (\$550 annual fee and \$2,500 inspection deposit) during the application approval process.
- 2. Sign Agreement—The annual agreement will be sent to the engineering contact via DocuSign.
- 3. Submit Master Model Listings—Register all current production models through ECT.
- **4. Schedule Inspection**—Models are inspected annually to ensure each craft is compliant with the ABYC Standards for the corresponding model year.
- **5. Variance Response**—If there are variations noted during inspection, a variance response outlining corrective actions is required within 30 days of inspection.
- **6. Consumer Satisfaction Index (CSI)**—NMMA Certified builders must implement an in-house CSI program to receive product and experience feedback from customers.
- **7. National Insurance Crime Bureau (NICB)**—If selling boats in the United States, register vessels with the national database of vessel information by contacting Donna Conick at dconick@nicb.org.
- **8.** Complete Compliance Specialist Exams—Attend NMMA Engineering Compliance Seminar at least once every two years and pass applicable Compliance Specialist exam annually.

# DISCOVER BOATING\*\*

Discover Boating support is a requirement to maintain NMMA membership and certification status including discounted rates at NMMA boat shows.

- 1. Engine manufacturers provide sales data based on horsepower to NMMA which is then invoiced to boat builders 45 days from membership approval. Assign Discover Boating billing contact.
- 2. Designate key personnel to manage the Discover Boating boat brand listings and lead retrievals.
- 3. Provide boat brand(s) to be included on the Discover Boating Boat Finder tool.
